The Governing Body normally meet twice termly. Due to the lockdown for COVID-19 all meetings since 19 May 2020 were conducted remotely. Governors reviewed their Committee structure in September 2019, and have two Committees: Finance and Premises Committee and Pay Committee. Governors meet regularly with Senior School Leaders to monitor areas identified as key for development, reporting each term to the Governing Body

Governors are required to publish their attendance at full Governing Body meetings and Committee meetings for the last academic year. This requirement also applies to Governors who have stepped down (or completed their four year term) in the last twelve months. Governors no longer in post are listed at the bottom of the table below.
